## **ICD TARIFF**

### **Terms & Conditions:**

1. GST and other Taxes if any will be charged extra as applicable.
2. DGDC/ICD will put its best efforts to move the containers in time between ICD, Sachin and JNPT/empty Yards. But if there are delays due to Port congestion/Traffic conditions or any other circumstances, DGDC will not be responsible and will not borne any expenses /cost due to delay/damages/demurrages.
3. Transportation of the containers /goods will be at Owner's risk. Consignee/Consignor has to insure their cargo in all respects. Any loss in the Govt. Taxes / customs duty / GST or any other Govt. liability, due to any event / incidence is the total responsibility of the consignee / consignor.
4. DGDC/ICD will not be responsible for the delay in shut out /loading or unloading/ storage charges levied at Port.
5. In case of default on payment, ICD will have right to hold the containers of defaulter till all the charges applicable including penalty is paid to DGDC/ICD.
6. It is sole responsibility of Consignee/Importer/Exporter to pay the demurrage charges and Containers will not be released / delivered unless all charges including the full demurrage charges are paid to DGDC/ICD.
7. It is understood and agreed that movement to and fro ICD and Clearance of containers is under compliance to these terms and conditions.
8. Tariff subject to changes without notification.
9. Subject to Surat Jurisdiction.
